LEGISLATIVE UPDATE – NAFTA 2.0



- Political Undercurrent
 - "NAFTA is the worst trade deal maybe ever signed anywhere but certainly ever signed in this country." --- Candidate Donald Trump
- Focus
 - Trade deficits
 - Reshoring American jobs
- Parties close to a deal
- Ability to get Congressional approval up in the air

LEGISLATIVE UPDATE - NAFTA 2.0



- Major Renegotiation Issues
 - Investor State Dispute Settlement
 - 5-year Sunset Period
 - Agriculture
 - Digital Trade
 - Intellectual Property
 - Currency
- Rules of Origin on Autos



LEGISLATIVE UPDATE - TARIFFS



USTR Section 232

- Pursued to protect national security interests
- Specified steel and aluminum from all countries
- Country exemptions (until May 1)
 - Argentina, Australia, Brazil, Canada, EU, Mexico
- Longer term exemption for South Korea, but 70% quota
- Product exclusions
 - Commerce Department Process

USTR Section 301

- Investigation into IPR violations from China
- 25% tariff on goods equaling \$50 bil
- 1,300 products listed in NPRM
- No exclusion process
 - Public comment period prior to passage
- HTS 8708 Motor Vehicle Parts not listed but a number of parts or subcomponents listed elsewhere
- MEMA webinar on topic

LEGISLATIVE UPDATE – AVS



- House passed HR 3388 "Self-Drive Act"
- Senate Commerce Committee approved S 1885
- MEMA Priorities:
 - Supplier ability to test AV systems on public roads
 - Distinction between federal and state regulation
 - "Data Access Advisory Committee"
 - Inhofe amendment
 - Report in two years on ownership, control and access to vehicle data
 - Committee members OEMs, OE dealers, equipment manufacturers, aftermarket parts suppliers
- Senate: three holds on the bill
- Ongoing Outreach:
 - Alliance, Global, Disability, Ridesharing, Tech, ITS, Telematics Task Force

LEGISLATIVE UPDATE – DMCA



- 7th Triennial Review
- Oct. 26 Proposed Rule: "Exemptions to Permit Circumvention of Access Controls on Copyrighted Works"
- Comment Period: Dec-Mar
- MEMA Action:
 - December Requested USCO to adopt an exemption because it does not circumvent technological protection measures (TPMs) 'on behalf of' consumers or conflict with DMCA anti-trafficking provisions
 - March Addressed software outside the context of diagnostics/repair (e.g. re-flashing)

 - Supports development of SVI
 - Must collaborate with various stakeholders OEMs, IAM, collision industry, etc.
 - Supports development of marketplace solution:
 - Secure
 - Neutral
 - Pass-through
 - Agreements by data owners/providers and users
 - Planning a comprehensive study to identify best solution, partners, success path
